Period of Performance

The Services shall commence on November 1, 2014, and shall continue through March 31, 2016.

Engagement Resources

Child Flight aircraft & pilots, local community support including pilots. Sponsorship provided by ANZ, Z Avgas, CTC Aviation, Trust Waikato, GoBus, Brian Perry Charitable Trust and other commercial sponsors.

Scope of Undertaking

To provide flights for special needs kids and support for Sommerville Special School by helping raise funding for sensory equipment and playground equipment and other projects on an ad hoc basis.

Child Flight gives free flights. During 2014-16 years we also hope to raise funds for essential school equipment which is not funded by the Government.

We are setting a target of at least 10 flights for Sommerville Special School by raising funding from local sponsors. Eventually during the course of the 2014-16 years we hope to raise at least \$5K for essential school needs NOT funded by the Government.

Deliverables

Aircraft and Pilots are provided free of charge to the school. Local funding for flights will hopefully elevate our profile in the Auckland community which should help develop a platform to launch other fund raising for special equipment not funded by Government.

Child Flight Responsibilities

We ensure that the pilots are properly qualified with current medicals and pilot licenses. All aircraft are registered with Child Flight which ensures they have current maintenance certificates and that all other certificates required to be carried by the aircraft are in the aircraft and up to date. Our aircraft are always flown with either two pilots or if only one pilot is flying a suitably qualified special needs person in the front RHS.

Sommerville Special School Responsibilities

Sommerville Special School profiles the passengers which should be aged 10 and over. No passenger can exceed 70kgs, unless total weight for 3 passengers is under 210kgs total. The passengers must be accompanied by a parent or knowledgeable care person. If there are two students flying together, they must be comfortable with each other. The school will provide a container which can be used during the flight should one or both students become airsick. It is the school's responsibility to obtain written approval from the parent/s.
